As the family's income rises, a portion of that increased income is deposited in an interestbearing escrow account. If the family successfully completes its Family Self-Sufficiency contract, the family receives the escrow funds that it can use for any purpose, including paying educational expenses, starting a business or paying debts, according to HUD.
