COMMISSIONER'S FINDINGS/REGULATORY CONDITIONS

The proposed activity will affect the 100-year floodplain of Norwalk River and Norwalk Harbor.

According to CGS Section 25-68d(d), the commissioner, after public notice of the application for exemption and an opportunity for a public hearing in accordance with the provisions of this Section, may approve such exemption if he determines that the agency has shown that the activity or critical activity is in the public interest, will not injure persons or damage property in the area of such activity, complies with the provisions of the National Flood Insurance Program, and, in the case of a loan or grant, the recipient of the loan or grant has been informed that increased flood insurance premiums may result from the activity or critical activity. The agency has determined that the proposed activity meets these requirements and recommends issuance by the commissioner of an approval of exemption for this project.
